Who We Are

The International Federation of Compliance Associations (IFCA) was formed in Dublin on November 23, 2010 and is the umbrella organization for professional Associations specialising in compliance and supporting the compliance profession. The objective of the organization is to improve services to our members by pooling knowledge and sharing information and best practices regarding different business models and service offerings.

The Purpose of IFCA is to be the global voice of the Compliance Profession and:

- the enhancement of member services of each IFCA Member Association;
- the coordination and development of programs and procedures designed to assist in the development of the compliance and business ethics profession;
- the development of standards for the mutual recognition of compliance and business ethics professional qualifications;
- the development of standards for the mutual recognition of compliance and business ethics standards; and
- to share information regarding best practices, procedures, and service offerings of IFCA Members.

Membership of IFCA is open to any Association of compliance professionals which:

- Is a non-profit organization
- Is a membership-based organization
- Whose objectives are aligned with the purposes of IFCA

While some countries may have more than one professional organization representing the compliance and ethics profession, membership of IFCA is limited to **one** IFCA Member per country. Each IFCA Member warrants that it is active in, and has substantial member representation in, the country or countries in which it has its primary incorporation.

Internationally Certified Compliance Professionals (ICCP)

Being a compliance professional requires the necessary knowledge, skill, leadership, experience, and commitment to continued professional development.

There are many core competencies and key areas of knowledge that are required, no matter the jurisdiction in which you are operating.



IFCA, as a group, conducts comparisons between the certification programs and requirements of its member organizations, and provides the added member benefit of recognition of equivalence if there is sufficient consistency between the various programs.

Members of the following IFCA Associations who have successfully obtained the noted accreditations or certifications from one member association, at the specified level, are currently be recognised by IFCA members as Internationally Certified Compliance Professionals (ICCP).

- **Licentiate** of Compliance Institute (LCI) - Compliance Institute (Ireland)
- **Associate** of Compliance Institute, Nigeria (ACIN): Compliance Institute, Nigeria (CIN)





IFCA Membership Criteria

The acceptance process of new members will have two phases:

Phase 1

Initial acceptance as a Provisional IFCA Member without voting rights.

- The applying Association should be open to and preferably have legal entities and individuals as members.
- Consideration will be given to a balance between private corporations, government agencies or entities (totally or partially owned) and non-profit organizations.
- Consideration will be given to maintaining a balance between, consultants or law firm personnel and people that work in an organization as a compliance professional or practitioner.
- Demonstrate a focus on compliance- related education / promotion of compliance culture / professional development and certification of compliance officers.

Phase 2

Final acceptance as a Full IFCA Member with voting rights.

- Provisional member should demonstrate progress on its work plan and the achievement of its objectives and evidence growth in its membership as well as in diversifying its composition, e.g.:
- increase in the number of legal entity members;
- increase in the composition of individual members.
- number of specific initiatives completed to support each of the objective areas, i.e., education, promotion of compliance culture, development, and certification of compliance officers.
- have an approved strategic plan. Provisional member must have attended and participated in all IFCA meetings.
- Members will verify if the applicant is the most representative association in the country.
