The Stock Exchange of Hong Kong Limited ("SEHK") has amended its Listing Rules, including the Corporate Governance Code ("CG Code"), to enhance the corporate governance framework and promote good governance among issuers. ECS - On Friday 25 March 2022, the European Commission and the United States announced that they have agreed in principle on a new Trans-Atlantic Data Privacy Framework, which shall foster trans-Atlantic data flows and address the concerns raised by the Court of Justice of the European Union in the Schrems II decision of July 2020.
